7. HANDLING AND STORAGE

Precautions for Safe Handling	Avoid generating dust. Use smallest possible amounts in designated areas with adequate ventilation. Wear appropriate protective equipment to prevent inhalation, skin and eye contact. Ensure a high level of personal hygiene is maintained when using this product. That is; always wash hands before eating, drinking, smoking or using the toilet.
Conditions for Safe Storage	Store in a cool, dry, well-ventilated area, out of direct sunlight and moisture. Store in labelled, containers. Keep containers tightly closed. Store away from water and incompatible materials. Have appropriate fire extinguishers available in and near the storage area.
